

Accredited installers will be able to unlock battery rebates of up to \$500* for the sale of a Qcells Q.HOME CORE energy storage system, a tailored battery energy plan and Virtual Power Plant (VPP).

By helping your customers spread the cost of a solar battery system for up to 10 years as well as unlocking monthly bill credits of up to \$30 through Qcells' Arcstream Energy Plan and VPP - this program will enable customers to combine their battery finance repayment with their energy plan subscription in one monthly bill. In addition, we provide you an opportunity to grow your business and offer a unique point of difference in the market.

What is the offer?

How do I apply?



1

Solar battery quote acceptance

Installer provides a quote for the Q.HOME CORE solar battery system and provides the customer with the Qcells product flyer.



2

Plenti finance application

Installer submits a finance application via Plenti's broker portal. At this point, the customer will be required to acknowledge the finance terms and conditions.



3

Conditional approval rebate confirmation

Upon receipt of a Plenti finance application conditional approval, the installer will receive a voucher code which will be required to present to Qcells at time of battery purchase order to claim their \$300 rebate.



4

Installation of solar battery system

If in possession of a Q.HOME CORE system, installers can commence the installation of the solar battery system.



5

Loan funds disbursement

After installation is completed, installers must log into their Plenti portal and submit the relevant settlement information and confirm installation. Upon successful completion, loan funds will be disbursed directly to the installer's nominated bank account. Typically, funds are received within 24 hours.



6

Qcells connects the battery to their VPP

If the customer elects to take advantage of the Arcstream VPP bill credits, then they will be required to switch energy providers and sign up to an Arcstream energy plan and VPP via Plenti's finance application journey (when available) or via an Arcstream online landing page.

FAQs

The customer is already on an energy plan with a solar FiT, will they have to go on a new plan?

Yes. The customer will be required to switch to the Arcstream by Qcells energy plan to connect to the VPP. The Arcstream energy plan replaces the solar FiT with a guaranteed \$30 monthly credit for participating in the VPP (and in Victoria, the mandated minimum 5.2c solar FiT is also retained). The customer is free to leave the VPP at any time with no penalty.

What is the Arcstream energy plan pricing?

The energy plan is charged as a simple subscription – one monthly price to cover access to green grid energy, membership of the Arcstream VPP and monthly guaranteed VPP credits, and up to 200kWh per month of green grid energy. Like a broadband or mobile data plan, customers can use more electricity than their allocation in any month and will be charged a competitive flat 30c per kWh for any additional electricity. There are no daily supply charges, no variable rates, no discounts, and no additional charges. The energy plan subscription prices are subject to change over time.

My customer has an existing solar system, are there any minimum requirements to connect to the offer?

The solar system needs to be between 5kW and 9.5kW and operational.

Who does the Qcells rebate get paid to?

Upon receipt of a Plenti finance application conditional approval, the installer will be required to present this to Qcells at time of battery purchase order to claim their rebate. The rebate will be applied to the wholesale price of the solar battery system.

Can I sign up customers who have previously installed a Q.HOME CORE battery on Plenti finance to the Qcells solar battery rebate program?

The solar battery rebate is only applicable to new purchases and installs of Q.HOME CORE solar battery systems.


